- > Dismantling the stand before the start of the official dismantling period on the last day of the fair is not permitted. In the event of non-compliance, a contractual penalty of 15% of the net rental price.
- > Exhibitor claims must be asserted within 2 weeks of the end of the trade fair, otherwise they shall be forfeited.
- > If the application is canceled before admission, a processing fee of € 300 excluding VAT will be charged.

Upon receipt of the application, the organiser is entitled to charge an initial advance invoice of 25% for the stand space and other costs already known. The remaining amount of the stand space rental plus other costs will be invoiced by the organiser no later than 4 months before the start of the trade fair. All amounts invoiced by the organiser are due for payment without deduction within 14 days of the invoice date.

The exhibitor can book additional services (e.g. guest passes, advertising material, electricity, water, telephone, etc.) via the online ordering system at www.husumwind.com. The Organiser may also charge a deposit of 25% for booked services.
